The successful bidder shall make his own arrangement for the purpose of taking delivery of auctioned vehicle.

- It shall be presumed that the bidder has fully inspected the car before the auction. The Embassy of India will not be responsible and shall not entertain any complaint in future in respect of any defect in the vehicle.
