After the deposit, the vehicle will be handed over to successful bidder, after executing necessary documents. The successful bidder shall make his own arrangement for the purpose of taking delivery of auctioned vehicle.
- Embassy of India, in its discretion reserves the right to reject or accept any or all the bids at any time, without assigning any reason thereof.
- It shall be presumed that the bidder has fully inspected the car before the auction. The Embassy of India will not be responsible and shall not entertain any complaint in future in respect of any defect in the vehicle.
- The successful bidder shall get the vehicle transferred in his/her name as per rules, at his own cost and responsibility, immediately. The Embassy of India shall not in any manner be concerned with or responsible for registration of the vehicle, and will have no liability whatsoever.
